Advising Information: Contact the [Student Success Center](#) for assistance with advising and registering for classes.

To be eligible for the tuition discount, the student/employee or dependent must maintain at least a "C" (2.0 on a 4.0 scale) in the courses for which he/she receives tuition assistance. A minimum Grade Point Average (GPA) of 2.00 must be maintained in order to be eligible for the tuition discount. Failure to meet this grade minimum will result in the student's having to pay tuition for the courses taken until his/her average grade is a "C" or better.
